Initial Planning Conference Participant Guide

Fredericton, New Brunswick February 21st, 2018



Overview

On October 3 and 4, 2018, New Brunswick Power (NB Power) will host a full scale nuclear emergency response field exercise called "Synergy Challenge 2018" at the Point Lepreau Nuclear Generating Station (PLNGS), in partnership with the Province of New Brunswick Emergency Measures Organization (NB EMO) and supported by regional, provincial, and federal institutions.

The purpose of this initial planning conference (IPC) is to introduce participants to Synergy Challenge 2018 and to provide interested organizations with the information required to determine how they can fit into the overall exercise picture. Organizations that have a role in the overall response to, and recovery from, a nuclear event at PLNGS have been invited to participate in this conference. Organizations will be provided options with respect to scope of play based on their own objectives and available resources for the exercise.

Participants will also have an opportunity to liaise with Exercise Design Team (EDT) members and other confirmed participating organizations to help determine how their own objectives can be achieved within the exercise parameters.

What to Expect

- Knowledge of current stakeholder objectives and their commitment to the exercise
- Details on exercise logistics, scope and constraints
- Details on the exercise planning process
- Information regarding the exercise evaluation methodology
- An opportunity to network with participating organizations
- An opportunity for organizations who are interested in participating to meet with the EDT, ask questions, and gather information that will assist in determining their level of participation
- Details on how organizations can get involved in the exercise

Objectives

The Tier One Objectives for Exercise Synergy Challenge 2018 have the consensus of all participating organizations and include:

- Validate the preparedness of Point Lepreau Nuclear Generating Station, NB Power, government and non-government organizations and agencies to respond to a Beyond Design Basis Accident (BDBA);
- Test the interoperability of participating organizations and coordination of response efforts;
- Test the interoperability of participating organizations and coordination of recovery efforts following a release of radioactive material to the environment;
- Validate current on-site and off-site Nuclear Emergency Plans; and
- Produce a joint evaluation report on the interoperability, coordination, and integration of participating organizations during a simulated nuclear emergency at PLNGS.

Participating organizations will be asked to develop their own Tier Two and Tier Three objectives that support the overall Tier One objectives. These detailed objectives will address specific plans and areas to be tested by each organization during Synergy Challenge 2018.
